# Application Acceptance

Membership commences once membership fees have been received, and the Secretary has entered the person's name, address and date they became a member on the members register held with Tennis Australia.

#### Membership year

The financial membership year runs from 1st September to 31<sup>st</sup> August. Also see Pro-rata fees below which applies to new competition members only. Membership renewal payments are due by 15<sup>th</sup> September.

## Tennis Victoria fee

Membership fees include Tennis Victoria Affiliation fee component which also covers public and personal liability insurance. Once fees are paid your details will be entered on Tennis Australia database which confirms your membership with our club and allows participation in competitions entered by our club.

#### Gate Locks

Once fees are paid, adult/family memberships will be provided with a code to open gate padlocks to the main gate and porous courts. Codes are not available to Night Social members or Junior membership. Junior/Adult/Family members must use 'Book a Court' to access courts 1-4 and court 9 free of charge. # Pro Rata fees

Pro rata fees will apply to new competition members first joining the club. Pro-rata fees are calculated on the number of whole months from the date of application to 31<sup>st</sup> August next year. Social memberships are for 12 months from the time the payment is received. Pro rata is not available for social memberships.
